

# General statement on Arla Foods' position on palm oil

Arla Foods acts responsibly and we strive to make our products in the most sustainable way possible. Palm oil has many uses and benefits, and palm oil based products and ingredients are used in some of the products produced by Arla, although quantities may vary over time.

Palm oil production can have an unjustifiable impact on the environmental and society if not responsible managed. Arla is committed to responsible and sustainable palm oil sourcing for the benefit of consumers, the environment, local communities, the business and its brands.

## Arla's principles for the purchase of palm oil

- Arla's ambition is to buy only segregated, certified, and traceable palm oil products and ingredients.
- Arla has decided to buy Green Palm certificates for all palm oil that is not delivered according to a physical certified supply chain in the intervening time.
- Time frame, see below.

As a basic step, Arla only purchases palm oil from suppliers who are members of the RSPO and who source their raw material from producers who also are members of RSPO.

We require all our suppliers of physical palm oil to be progressing on certification of their plantations and mills, as well as refineries and processing plants. We expect them to communicate a time-bound plan for achieving this, and to report progress towards their goals in an annual communication of progress (ACOP).

Furthermore, we want to strengthen our commitment to work towards a more sustainably produced palm oil supply chain by including additional specific demands on the suppliers and their sub-suppliers. This includes demands of no deforestation, no new development on peat lands, achievement of full traceability to the source (e.g. smallholders, a group of smallholders or a plantation) and respect for workers', local communities' and human rights. We demand that our suppliers place the corresponding demands within their supply chains, including time bound plans and measureable milestones, in order that their suppliers also commit to sustainable palm oil production and supply chain.

We also expect our suppliers to report publically the environmental impact of their full supply chain and their progress to reduce and minimise GHG emissions.

### Arla's time frame

Arla will only use segregated certified palm oil-based products by the end of 2015.

Arla request full compliance with additional criteria of no deforestation, not exploiting new peat land and with traceability from plantation / smallholder level by the end of 2015 or if clear time bound plan presented 2015 prolonged until 2017 at the latest.

How far we get in 2014 is dependent upon the availability of products.

Arla has decided to buy Green Palm certificates for all palm oil that is not delivered according to a physical certified supply chain during that time.

Suppliers of additives and compounds which use palm oil as an ingredient, will be expected to use only certified segregated palm oil by no later than the end of 2015, and comply with the additional demands no later than by the end of 2017.

## Monitoring and follow up

Procurement of palm oil follows Arla's general procurement management process. Assessment of suppliers, monitoring of development, follow up and handling of deviations will be handled according to these processes.

### Arla's achievements so far

2011 and 2012: Green Palm certificates were purchased corresponding to the entire volume of palm oil and palm oil based products used in Arla's supply chain.

2013: approximately 20 % of the total volume used, for both Arla branded products and 3<sup>rd</sup> party production, was certified segregated. The remaining volume was covered by Green Palm certificates.

In 2014, our aim is that not less than three quarters of the total volume of palm oil we purchase is certified segregated. The remaining volume will be covered by Green Palm certificates.

The continued progress we make in achieving our ambition will be shared publically in our annual CSR Report as well as in our annual code of progress report to RSPO.

### **Next steps**

By no later than the end of 2015, all palm oil and palm oil products used in the whole of our supply chain will be segregated palm oil (CSPO) produced by RSPO members that are either 100 % certified, or have a time bound plan to be 100 % certified within 2 years.

By no later than the end of 2017, all palm oil and palm oil products will come from 100 % RSPO certified growers, that have been independently verified as implementing the additional demands set out in Appendix 1.

## **Appendix**

### **Arla and RSPO**

Arla applied for, and was granted, membership in the multi-stakeholder organisation Roundtable on Sustainable Palm Oil (RSPO) in December 2012.

The RSPO certification standard is developed through a global, transparent, multi-stakeholder dialogue and requires 3<sup>rd</sup> party certification. It includes strict principles and criteria and is seen as a viable solution and a credible base on which to build.

We want to participate in the development of the standard's ambitions within its framework and we want to support progressive and proactive growers and millers.

We demand that breaches (violations) of the standard to lead to clear and immediate action plans with defined time frames.

We support the RSPO's vision of 100 per cent sustainable palm oil production and the development presented in April 2014, driven by POIG (Palm Oil Innovation Group) as we truly believe this is in the best interests of the environment and climate, endangered species, local communities, indigenous people as well as people working in the palm oil supply chain.

## **Explanations / Clarifications of demands**

### Traceability means

- Traceability to mills, plantations or smallholders / group of smallholders, meaning information about geographic origin of all raw materials to mills should be registered and documented to traceable area of origin and supplier/group of suppliers.

#### No deforestation means

- No clearance of rain forest or HCS forests
- Areas of high carbon and high conservation value (HCV) shall be protected
- Farms and plantations shall comply with local legislation
- Farms and plantations shall comply with RSPO's criteria for sustainable production

## Protection of peat land means

- No new peat land, regardless of depth, shall be introduced to palm oil cultivation
- Existing plantations on peat land shall implement best practices to protect the environment and minimise carbon emissions
- Existing plantations shall comply with RSPO's criteria for sustainable production and with local legislation

Respect for workers' rights, human rights and the local communities rights

- Not exploit workers or community
- Respect ILO Convention 169
- Respect and support UN Declaration of Human Rights and on Indigenous People's Rights
- Comply with local and international legislation
